- 3. Technical Bids were opened online e-tendering method by the Technical Bid Opening Committee on 29.05.2025. A total eleven bidders had uploaded the technical bid on e-Proc2 portal. Further, in the technical committee meeting dated 29th May, 2025, the date mentioned in the 1st line of proceeding "29th June, 2024" may be read as "29th May, 2025".
- 4. The technical committee has evaluated the bids as per the eligibility criteria mentioned in the NIT.
- 5. Three out of eleven, have submitted financial bid also along with the technical bid. Clause 9.2 of Section II of the NIT states that uploading of the financial bid in the technical bid will result in rejection of the tender. Technical Committee recommends to reject the bid of these three bidders namely, M/s J Singh & Associates, Chartered Accountants, M/s S L Chhajed & Co. LLP, Chartered Accountants and M/s M A P S S AND COMPANY, Chartered Accountants.
- 6. One bidder namely M/s Komandoor & Co. LLP, Chartered Accountants had submitted the documents as per the eligibility criteria mentioned in the tender documents.
- 7. In the bid documents of the remaining seven bidders, besides non-submission of certain documents such as firm constitution certificate, CV of Key members, COP of partners, certain discrepancies have also been found, such as documents not clearly readable *i.e.* hazy, self-attestation not done etc. Earlier, the technical committee had recommended to ask these bidders to resubmit the missing documents, as well as documents that are not readable through e-mail within 2 days. Accordingly, opportunity was provided to these bidders and in response, six bidders resubmitted the desired documents through email and one bidder through eproc2 portal.

10. As discussed above, only six bidders have been found technically qualified against the technical eligibility criteria. Bids of three bidders are rejected in terms of clause 9.2 of Section II of the NIT and the remaining 02 bidders have been disqualified as per the reasons mentioned in clause-09 above. 11. Since, Six bidders have qualified the technical eligibility criteria; the financial bids can be opened. It is recommended by the technical committee to open the financial bids of these six bidders and select an agency which is as per the Least Cost Selection (LCS) method mentioned in Tender documents.
