Proceeding of the Project Appraisal Committee (PAC) meeting held on 2nd June, 2025 to open financial bids of technically qualified bidders for selection of agency for Rate Contract to supply 'Nayi Pehal Kit' across all the Districts in the state of Bihar

With reference to the Notice Inviting Tender (NIT) Reference No.: -"03/SHSB/FP(Nayi Pehal Kit)/2025-26" for the selection of agency for rate contract to supply 'Nayi Pehal Kit' across all the districts in the state of Bihar, published in leading newspapers bearing PR. No. 001248(B&C) 2025-26 and uploaded on the website "<https://eproc2.bihar.gov.in>" and "<https://shs.bihar.gov.in>", the Project Appraisal Committee (PAC) meeting was held on 2nd June, 2025 at 11:30 AM in the Conference Hall of the 'State Health Society, Bihar (SHSB), Shwathya Bhawan, Sheikhpura, Patna-800014' to open of the financial bids of technically qualified bidders.

3. Only one Bidder, **Trade Supply (India)** was present during the Financial Bid Opening before the Project Appraisal Committee.
4. The technical committee has evaluated the bids as per the eligibility criteria mentioned in the published tender (RFP/NIT/Corrigendum) documents and the technical committee recommended five bidders for technically qualified for opening of financial bid, details as follows:-

5. The Financial Bids were opened online e-tendering method by bid opening committee in the presence of the Project Appraisal Committee, for below mentioned 5 (five) technically qualified bidders and the details of Financial Bids of 5 (five) bidders are as under:




Note: GST if applicable will be paid by the State Health Society Bihar (SHSB), as per the prevailing rates/ rules.


6. In light of the above, the Project Appraisal Committee (PAC) evaluated the financial bids of the technically qualified bidders as per Least Cost Selection (LCS) method and after evaluation recommends to select “**Trade Supply India**” as L-1 bidder for supply of ‘Nayi Pahal Kit’ in terms of the tender floated by the SHSB.
7. Further, as per the clause 8.5, Section-III of the NIT, the SHSB reserves the right, as its sole discretion, to select one or more additional technically qualified bidder(s), in addition to the L-1 bidder, for the purpose of award of contract at the rate quoted by the L-1 bidder. However, such selection shall be subject to the acceptance of the L-1 rate by the respective bidder(s). SHSB further reserves the right to allocate one or more Clusters to any of the selected bidder(s), and such allocation shall be final and binding.


In terms of the above provision, keeping in view the volume, hassle-free and timely supply of the material, if desires, SHSB may negotiate with L-2 & L-3 bidders, whose rate is very close to L-1, to supply the kit on L-1 rate..

8. It is also recommended by the Project appraisal committee (PAC) that in case if the selected bidder fails to honour the Letter of Intent (LoI)/Contract agreement, the SHSB shall be at the freedom to negotiate with the other responsive bidder i.e., with the next lowest financial value L2, L3.... (in this order) with their consent to enter into an agreement with SHSB, to provide the services at L1 rate and for said denial/failure if any, the EMD of the concerned selected bidder (L-1 bidder or L2/L3 bidder as per clause 7 above) will be forfeited and his LoI shall be cancelled.




