Notice Inviting Tender for Hiring of Transport Services to Transport Drugs, Consumables, Family Planning Commodities & Other Supplies in the State of Bihar

1. The State Health Society, Bihar (SHSB), Patna intends to select agency via e-tendering for providing transport services to transport drugs, consumables, family planning commodities and other supplies till lowest level health facilities in all the districts of the State. Three levels of transportation services shall be provided within a district:

- (a) **LEVEL-1 (L1) TRANSPORTATION:** From State/ Regional Warehouses to District Drug Warehouses
- (b) **LEVEL-2 (L2) TRANSPORTATION:** From District Drug Warehouse (DWH) of the district to District Hospital, Sub-Divisional Hospitals, Referral Hospitals, Community Health Centres, Primary Health Centres & Urban Primary Health Centres of the district.
- (c) **LEVEL-3 (L3) TRANSPORTATION:** From Community Health Centres/ Primary Health Centres to APHCs/HSCs/HWCs of their respective blocks of the district.

Bids are invited from eligible transporters/fleet operators. The period of the contract shall be three (3) years. The contract may be extended, with the mutual consent of both parties, for a maximum period of two (2) additional years, one-year extension at a time, subject to satisfactory performance and approval of the competent authority.
