CORRIGENDUM 2

1. With reference to Notice Inviting Tender: e-tender (NIT) Reference No. 04/SHSB/IEC (Empanelment of Event Management Agency)/2026-27 for "Notice Inviting Tender for the Empanelment of Event Management Agency for conducting various Melas/Health camps/Events etc." for State Health Society, Bihar, published on the website "https://eproc2.bihar.gov.in", and in continuation of Corrigendum-1 issued in respect of the said tender.

2. As per the information received from the IT expert, once a bidder has submitted the EMD, no modification regarding EMD exemption or any change in the EMD amount can be made thereafter on the eproc2 portal. Therefore, considering the technical limitations of the portal, the provision for EMD submission in the tender is hereby retained as it is.

3. So, The Competent Authority, SHSB, has decided on the following amendments to the RFP, covering (i) extension of the bid submission timeline by 09 (nine) days with consequential revision of the Schedule of Events, and (ii) revocation of the Earnest Money Deposit (EMD) exemption granted to Micro and Small Enterprises (MSEs) vide Corrigendum-1:-

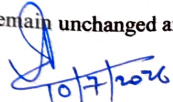

2	Section II – ITB, Clause 8.2, (as amended vide Corrigendum-1), Page 11	"8.2 It may be noted that no bidder is exempted from the deposit of EMD, except Micro and Small Enterprises (MSEs) eligible for exemption under the Bihar Purchase Preference Policy, 2024 , subject to submission of a valid Udyam Registration Certificate along with the bid. Tenders submitted without EMD, or without a valid Udyam Registration Certificate where EMD exemption is claimed, shall be summarily rejected, which shall be at the risk of the agency, avoiding any unwarranted litigation."	The EMD exemption granted to Micro and Small Enterprises (MSEs) vide Corrigendum-1 stands revoked/withdrawn with immediate effect due to above technical reason. Clause 8.2 shall stand restored to its original form as published in the RFP: "8.2. It may be noted that no bidder is exempted from the deposit of EMD. Tenders submitted without EMD shall be summarily rejected, which shall be at the risk of the agency, avoiding any unwarranted litigation." Accordingly, no bidder – including MSEs/Udyam-registered units – shall be exempt from submission of EMD ; all bidders, without exception, must submit the EMD as prescribed in Section I, Clause 9 and Section II, Clause 8.1 of the RFP.
3.	Section V, Eligibility Criteria, Sl. No. III (Turnover), Page 23	"The bidder must have Average Annual Turnover of Rs. 2 (Two) Crores in last three financial years (FY 2023-24, FY 2024-25 & FY 2025-26). Documentary Evidence: (i) Audited Financial Statement inclusive of audited Balance Sheet, Audited Profit & Loss Account/Income & Expenditure Account, along with related notes on account; (ii) Turnover certificate issued by Chartered Accountant (must be mentioned Membership No., UDIN No. & Date) certifying the turnover."	The bidder must have Average Annual Turnover of Rs. 2 (Two) Crores in the last three financial years (FY 2023-24, FY 2024-25 & FY 2025-26). Documentary Evidence: (i) Audited Financial Statements inclusive of Audited Balance Sheet, Audited Profit & Loss Account/Income & Expenditure Account, along with related notes on account; (ii) Turnover Certificate issued by a Chartered Accountant (must mention Membership No., UDIN No. & Date) certifying the turnover. For FY 2025-26 only, where the Audited Financial Statements are not yet finalised, Provisional Turnover figures duly certified by a Chartered Accountant may be submitted. However, in case the last due date for completion of the audit for FY 2025-26 is 30th September 2026 , the agency shall submit the original Audited Financial Statements and other related documents, along with the ITR for AY 2026-27, latest by 3rd October 2026 , either by email or in physical form to the office. The agency shall submit the following documents: (i) Audited Financial Statements , including the Audited Balance Sheet, Audited Profit & Loss Account/Income & Expenditure Account, along with the related Notes to Accounts; and (ii) Turnover Certificate issued by a Chartered Accountant , duly certifying the turnover and ITR for AY 2026-27. The certificate must clearly mention the Membership Number, UDIN Number, and Date of the Chartered Accountant.

3. All changes/modifications in the RFP as above are binding on all bidders.

4. Save and except as amended above, all other terms and conditions of the RFP, including those amended vide Corrigendum-1, shall remain unchanged and binding, as before.
